\*Gallons delivered over the contracted gallons will be billed at the retail price at the time of delivery.

\*All non-program invoices need to be paid for separately within our 30 day terms.

\*CV Oil Co. Inc. does not assume any liability for product run outs.

\*Customers are responsible for clear access to tank(s) in-order to make timely deliveries (snow removal, sanded driveways, vehicles, etc.).

\*New customers must agree to have a property inspection. This includes oil tank inspections and additional fees may apply.

\*Customer is committed to the contracted gallons. If there is a **BREACH** of contract, a penalty of \$250.00 plus \$ .50/gallon for every gallon not used. This serves as authorization to deduct such penalty and fee directly from your Pre-Buy credit balance.

\*Any unused Pre-Buy money will remain on your account for future use unless you request a refund. \*The contracted price is excluded from Fuel Assistance benefits. Fuel Assistance prices are determined by the State of VT. If you receive Fuel Assistance, your price will be the daily price that Fuel Assistance posts at the time of delivery.

\*If dramatic events (i.e. Acts of God, terrorism, war, strikes, embargoes, etc.), CV Oil Co. Inc. reserves the right to cancel any or all programs without notice or penalty. Offer stands only if there are gallons available for purchase.

\*Customers must be on automatic delivery throughout the contracted period.

\*Any new taxes or fees mandated by the state of Vermont or the Federal government will be a line-item charge and will be due within our 30 day terms.
