TERMS AND CONDITIONS

- *Minimum usage of **500** gallons annually to participate in the capped price budget plan.
- *This price does not include Fuel Tax, PDL Tax, or VT Sales Tax if applicable.
- *Budget customers need to start with a **full tank and a zero balance**.
- *Budget contracts are offered only to customers with open credit (no renters or COD customers).
- *All budget payments are due on the **15th** of the month starting August 15, 2024 and ending on May 31, 2025.
- *Budgets are based on annual usage and are merely an estimate.
- *C.V. Oil Co, Inc. reserves the right to cancel the budget plan if the payments are not made in a timely manner.
- *Gallons are available from August 15, 2024 through May 31, 2025. CV Oil Co, Inc. reserves the right to deliver product before or after these dates.
- *Gallons delivered over the contracted amount will be billed at retail price at the time of delivery with no additional discounts.
- *CV Oil Co, Inc. does not assume any responsibility for product run outs.
- *Customers are responsible for clear access of the driveways and tanks (snow removal, sanding, vehicles, etc.).
- *CV Oil Co, Inc. reserves the right to adjust the payment throughout the budget contract period if need be.
- *Past due budget accounts will be subject to a finance charge.
- *All budgets must be approved by CV Oil Co, Inc.
- *Any unpaid balances are due at the end of the contract period.
- *This contract price is excluded from Fuel Assistance benefits. Fuel Assistance price is determined by State of VT. You will be billed at the Fuel Assistance price on the day of delivery.
- *All non-program invoices need to be paid for separately, (i.e.) cleanouts, installations, grill tanks, other products) within our 30 day terms.
- *If dramatic events (i.e. Acts of God, terrorism, war, strikes, embargoes, shortages, etc.), CV Oil Co, Inc. has the right to cancel any or all programs without notice or penalty.
- * If you **BREACH** this plan in any way, you agree to pay CV Oil Co. Inc. a penalty of \$250.00 plus \$.50 per gallon for every gallon not delivered. This serves as authorization to deduct such penalty and fee directly from your credit balance.
- *All new customers must agree to a property inspection. This includes oil tank inspections and LP gas appliance inspections which may include an additional fee.
- *Any new taxes or fees that are mandated by the state of Vermont or the Federal government will be a line-item charge and will be due at the end of the contract period.
- *CV Oil Co, Inc. may withdraw this offer at any time.
